EQUIS European Foundation for Management Development	<ul> <li>european accreditation organization for Business Schools</li> <li>requires at least 25 full time faculty members</li> <li>has already accredited about 80 Business Schools worldwide</li> <li>process oriented validation</li> </ul>
FIBAA Foundation for International Business Administration Accreditation	<ul> <li>accrediting organization for Germany, Austria and Switzerland</li> <li>is directed by employer organizations</li> <li>only accredits Business Schools</li> <li>has so far accredited about 120 schools</li> </ul>
